What is the GNC Technical Alliance Consultant Roster?

- Candidates can be hired as consultants depending on personal availability and your needs.
- Recommendation of potential candidates from the Alliance Consultant Roster is fast (approx. 3 working days).

Who can use the GNC Technical Alliance Consultant Roster?

Any partner, agency, cluster, sector or technical working group in the country identifying a need for Nutrition staff support.

Who are the consultants recommended by the GNC Technical Alliance Consultant Roster?

Each application to the rosters undergoes a thorough selection process that may include a screening of candidates' CVs, a review of provided work samples, and technical testing. Contacting references for additional information, conducting interviews or other activities may also take place if deemed necessary. These steps are done to ensure high-quality vetted consultants meet your needs.

What does it cost to use the GNC Technical Alliance Consultant Roster?

Placing a request and receiving recommendations of candidates from the Alliance Consultant Roster is free of charge. The subsequent hiring process and fee negotiations are under the responsibility of the requestor.

How do I place a request to the GNC Technical Alliance Consultant Roster?

Fill in the Alliance Request Form, found here, detailing the nature of your request, and attach any relevant documents and TORs. Your request form will automatically be directed to the Roster Manager for review.

How is my request handled?

The Roster Manager will contact you within 1 working day after you have placed your

request to get any additional information that is needed and to explain the next steps.

- Within **3 working days** the Roster Manager will write back to you to recommend candidates for the position.
- It's now up to you to review the candidates and make a selection!
- We will be in touch later with a short evaluation about the request process and consultant performance.

How are consultants from the GNC Technical Alliance Consultant Roster hired?

Once you have selected your preferred candidate your agency is fully responsible to undertake all normal recruitment procedures prior to selecting and hiring a recommended candidate, including (but not necessarily limited to) the following: background checks, fee negotiation, confirmation of degrees and work experiences, reference checks, etc.

While the GNC Technical Alliance *screens and recommends* candidates based on their technical skills as evidenced in their CV, cover letter and samples of work, interviews and technical tests (related to the specific request) are not conducted with the candidate. Therefore, the GNC Technical Alliance cannot guarantee that the information provided by the consultant is an accurate and true representation of their skills and experiences. As part of the responsibility of the hiring agency, further interviews and technical tests should be conducted in line with the specific requirements of the position. As part of the GNC Technical Alliance Consultant Roster process, we do perform background checks.

How can I apply to be a part of the GNC Technical Alliance Consultant Rosters?

The applications for the rosters are open on an ongoing basis. Interested applicants can get more information and apply <u>here</u>.

Being part of the roster means that your profile went through a thorough vetting process and is available to any NGO, UN agency, or government partner worldwide who are regularly looking for consultants.

Once a person is placed on the roster, he/she will remain on the roster for up to 36 months, unless requested to remove him/her earlier.
